in consideration of One and No/100 (\$1.00)----- Dollars
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
Benjamin E. Boren, his heirs and assigns, forever-

ALL that certain piece, parcel or strip of land situate, lying and being on
the Southern side of Shannon Drive, being shown and designated on plat pre-
pared for Benjamin E. Boren and W. H. Howell, Jr., dated November 17, 1980,
and revised December 1, 1980, and recorded in the RMC Office for Greenville
County, S. C. in Plat Book 3-2, at Page 75, and having, according to
said plat, the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Shannon Drive at the joint
front corner of the premises herein described and property now or formerly
designated as Part Lot 65, Boren, and running thence with the line of proper-
ty now or formerly designated as Part Lot 65, Boren, S. 8-53 W. 41.6 feet to
an iron pin; thence S. 42-30 W. 194.4 feet to a point in the center of an
unnamed branch; thence with the center of said unnamed branch as the line,
S. 55-22 E. 25.44 feet; thence with a new line, N. 42-39 E. 214 feet to an
iron pin on the Southern side of Shannon Drive; thence with the Southern side
