and release unto Lee F. Alexander, James C. Alexander, and Artist F. Richards, their heirs  
and assigns forever,

ALL that certain tract of land near the City of Greenville in the County of Greenville,  
State of South Carolina, on the southwestern side of Edgemont Avenue Extension  
containing 1.7 acres, more or less, shown as Tract No. 5 of the J. B. Banks Property,  
according to a plat recorded in said RMC Office for Greenville County in Plat Book LL  
at page 151 and having the following metes and bounds, to wit:
