ARTICLE II

The Trustee is authorized in her absolute discretion with respect to the above described real property to sell, grant options to sell said property or mortgage said property without authorization by any Court or without authorization of the beneficiary of the Trust and her signature on any deed, option or mortgage shall be binding upon all beneficiares of this Trust and their heirs and assigns, forever. The proceeds from any mortgage may be used to improve said property or, if the proceeds are not used to improve said property, the proceeds shall be disbursed in accordance with Article I above. There shall be no duty upon the purchaser, optionee or mortgage to see that the sales proceeds, option proceeds or mortgage proceeds are administered in accordance with the terms of this Trust Agreement.
