in consideration of Nine Thousand Fifty and 00/100 (\$9,050.00) ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Lucy B. Foster, her heirs and assigns, forever:

All that lot of land with the buildings and improvements thereon in Greenville County, State of South Carolina, being known and designated as Lot No. 3, as shown on plat of Air Base Highlands recorded in the RMC Office of Greenville County, in Plat Book Z, at Page 195 and being more particularly described according to a recent survey by R. W. Dalton, November, 1951, as follows:

Beginning at an iron pin at the southwest intersection of Air Base Drive (formerly Old Augusta Road) and Ace Avenue, and running thence with Ace Avenue, N. 89-15 W. 110 feet to an iron pin at the joint corner of Lot No. 19 and Lot No. 3; thence with the line of Lot 19 S. 0-51 E. 50 feet to an iron pin at the joint rear corner of Lots 2 and 3; thence with the line of Lot 2 S. 89-15 E. 110 feet to an iron pin on the western side of Air Base Drive; thence with said drive N. 0-51 W. 50 feet to the point of beginning.
