in consideration of Seven thousand two hundred eighty one & 77/100 (\$7,281.77) and assumption of mortgage Dollars,

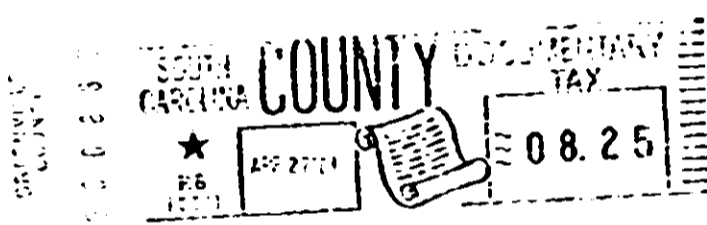
