Harvey hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee

ALL that lot of land with the buildings and improvements thereon, situate on the South side of Vanderbilt Circle, in the City of Greenville, in Greenville County, South Carolina, being shown as Lot 68 on plat of White Oaks Subdivision, Property of Northside Development Company, made by J.D. Pellett, Jr. in August, 1946, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "P", at page 121, and having, according to a survey made by R.E. Dalton, December 19, 1955, the following metes and bounds, to-wit:
