ALL that certain piece, parcel or tract of land situate in the County and State aforesaid, in Fairview Township, having the following metes and bounds, to-wit:

BEGINNING at a point, said point measuring a distance of 268.2 feet from the center line of Wilson Bridge Road (Georgia Road) and running thence N. 6-13 W. 57.9 feet to an old iron pin; thence 116 feet in a northeasterly direction along land now or formerly of West; thence 205 feet to a point along line now or formerly of Masters; thence 180 feet along said line to a point; thence 290 feet along land now or formerly of Gilbert to a point and continuing along land now or formerly of Gilbert 50 feet to a point; thence 390 feet to the point of beginning.
