the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Wayne H. Jackson and Carol I. Jackson, their heirs and assigns forever,

ALL OUR RIGHT, TITLE, INTEREST IN AND TO:

ALL that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Western side of North Main Street, and having, according to a survey prepared by Jones Engineering Service, dated May 15, 1980, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of North Main Street, which iron pin is located in a Northerly direction 325.3 feet from the intersection of Park Avenue and North Main Street, at the joint front corner of the property herein described and property now or formerly of Goldsmith, and running thence with the common line of said properties N. 77-21 W. 184.6 feet to an iron pin; thence N. 4-01 E. 91.7 feet to an iron pin; thence N. 17-01 E. 20.4 feet to an iron pin at the joint rear corner of property herein described and property now or formerly of Goldsmith; thence with the common line of said properties S. 71-35 E. 208.3 feet to an iron pin on the Western side of North Main Street thence with the Western side of said Street S. 19-16 W. 90.6 feet to the point of beginning.
