Ralph Reese and Maxine O. Reese, their heirs and assigns forever:

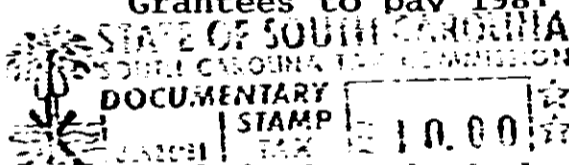
