in consideration of Forty-One Thousand, Five Hundred and No/100-----(\$41,500.00)----- Dollars,

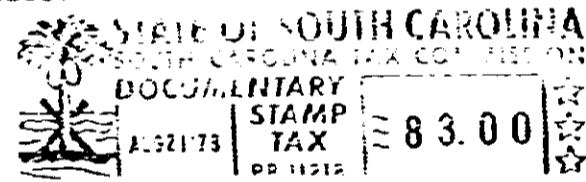
