Office for Greenville County, and also in Judgment Roll No. G-2699, Book 4, page 280 in the Office of the Clerk of Court for Greenville County, the surviving corporation of the merger being Fairforest Company, and its name was changed thereby to Reeves Brothers, Incorporated. Reeves Brothers, Incorporated was subsequently merged with Reeves Brothers, Inc. by merger agreement recorded in Deed Book 579, page 344, in the R.M.C. Office for Greenville County, and also in Judgment Roll No. G-7906 in the Office of the Clerk of Court for Greenville County, the surviving corporation of the merger being Reeves Brothers, Inc.
