POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS that I, Lina Marie Hirschowitz, a resident of the County of Greenville, State of South Carolina, have made, constituted and appointed and by these presents do hereby make, constitute and appoint Lina Marie Hirschowitz my true and lawful attorney.

My attorney shall have full power and authority to do and perform all acts and things whatsoever requisite, necessary or desirable in my attorney's judgment in or about my estate, whether real or personal, and whether now in being or hereafter acquired, as fully and forcefully, to all intents and purposes as if done by me personally. This power includes but is not limited to the power to enter into contracts; execute all papers, deeds, mortgages, notes and leases; accept and pay out monies in my name by way of check or otherwise; effectuate releases or compromises; sign affidavits; employ agents, contractors or employees; and institute, defend and settle lawsuits or other matters, all directly on my behalf and as if I had done so personally.

Any and all things done by my attorney shall be binding on me, my heirs, devisees, legatees, personal representatives or assigns as to third persons with whom my attorney will have dealt.

Notwithstanding the foregoing, my attorney shall hold this power in a fiduciary capacity and shall be accountable for his or her actions as such.

This power shall not be affected by physical or mental incompetency or incapacity which may render me incapable of managing my own estate, and is intended by me to be as lasting as the statutory law of South Carolina allows.

This power shall continue until such time as it is revoked by me or until my death.
