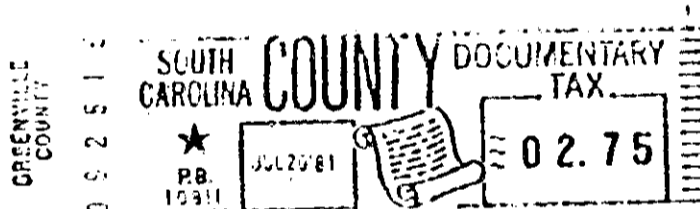
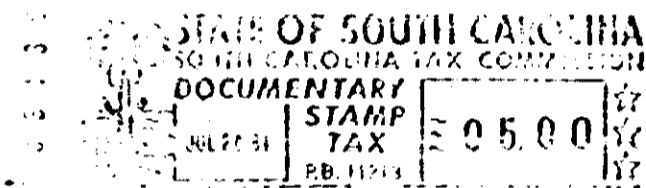
Two Thousand Five Hundred and no/100 (\$2,500.00)----- Dollars,
