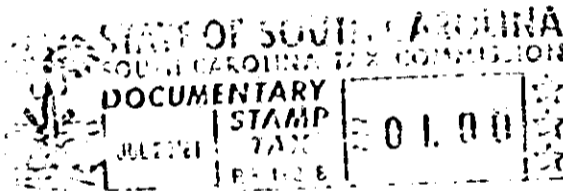

BEGINNING at a nail and cap in the center line of Chestnut Ridge Road and running thence along the center line of Chestnut Ridge Road S. 9-30 W. 69.05 feet to a nail and cap in the center line of Chestnut Ridge Road; thence turning and running N. 31-35 E. 77.9 feet to a point; thence turning and running along other property of the Grantors N. 88-05 E. 52.22 feet to a nail and cap, the point of beginning, said tract containing 1,767 square feet according to said plat.

This being a portion of the property conveyed to John H. Cothran and Edith G. Cothran by deed of R. B. Green dated May 11, 1971 and recorded on May 19, 1971 in the R.M.C. Office for Greenville County in Deed Volume 915 at Page 493.
