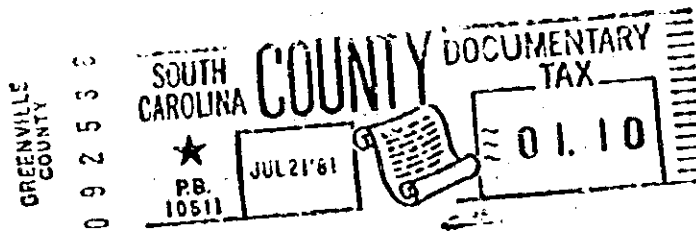
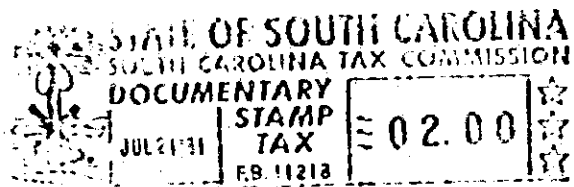

H. W. HEARST and MAMIE HEARST, their heirs and assigns forever:

ALL that piece, parcel or lot of land situate, lying and being in Gantt Township, County of Greenville, State of South Carolina, on the Georgia Road, as shown on a plat of the property of Hazel Cureton and Lula Chapman, by Jones & Southerland, Engineers, dated March 21, 1960, and having, according to said plat, the following courses and distances, to-wit:

19(45) 594.2 - 1-12 (NOTE)
