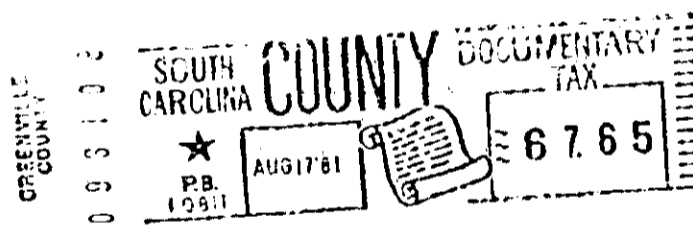
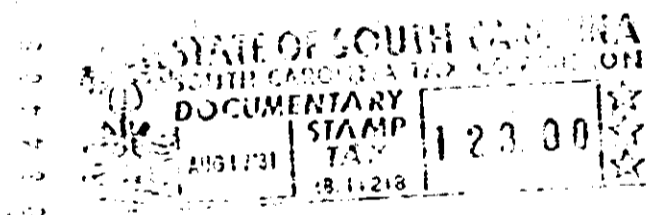
All that piece, parcel or lot of land together with all buildings and improvements
