Said easement is described as follows:

Said easement area comprises approximately 468.37 square feet on property further described below and shown at Block Book No. 201-1-3.

Said property is described as follows:

All that certain lot of land in the City of Greenville, County of Greenville, State of South Carolina, in a section known as Nicholtown; and having such metes and bounds as shown on deed from Rawlings, Inc., of Greenville to Alfred M.
