release unto CITY OF SIMPSONVILLE, SOUTH CAROLINA, its successors and assigns:

For consideration of One and No/100 (\$1.00) Dollar, the grantor herein
conveys to the grantee all of the roads and streets, including the
roadway, curb gutters and sidewalks in Section 2 of subdivision known
as POWDERHORN, said streets are named as follows:

Shiloh Court, Chickamauga Lane, Powderhorn Road and
Yorktown Court,

as shown on plat of said subdivision prepared by C. O. Riddle dated
September 20, 1977, amended June 6, 1978 and recorded in the RMC Office
for Greenville County in Plat Book 6H at page 49.

Together with the above conveyance, the grantor herein conveys to the
grantee all sewer pipes and connections which have been installed by
the grantor at the grantor's own expense, the same is inclusive of
all sewer facilities installed by the grantors in Section 2 of Subdivision
set out above.

As a part of the consideration for this conveyance, the grantee does
hereby accept full charge and responsibility for the upkeep and
repair of the streets and sidewalks herein conveyed and also the sewer
lines and connections conveyed by the grantor to the grantee without any
expense or charge against the grantors, their successors and assigns
forever.

appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s) heirs or
successors and assigns, forever. And, the grantor does hereby bind itself and its successors to warrant and forever defend all and singular
said premises unto the grantee(s) and the grantee's(s) heirs or successors and against every person whomsoever lawfully claiming or to
claim the same or any part thereof.
