T. Smith Estate, prepared by Dalton & Neves Eng., dated May, 1935, and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book H at Page 279, and having, according to a more recent plat prepared by Dalton & Neves, Eng., dated May, 1965, entitled "Property of Walter C.
