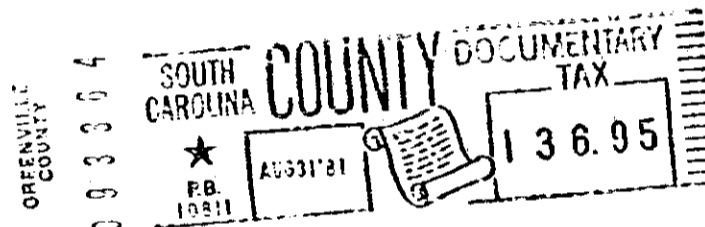
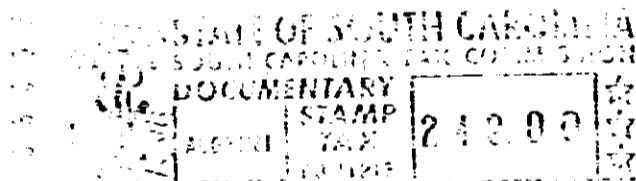
KNOW ALL MEN BY THESE PRESENTS, that Hamlett Builders, Inc. <sup>AUG 31 3 50 PM '81</sup>
