

South Saluda River; thence running along the centerline of South Saluda River, the centerline of which is the property line, the following traverses and distances: N. 59-14 W., 63.0 feet; S. 71-31 W., 67.7 feet; S. 60-16 W., 104.9 feet; N. 86-37 W., 166.0 feet; N. 65-11 W., 106.6 feet and N. 25-36 W., 114.0 feet to a nail and cap in the center of a bridge on Moody Bridge Road which spans the South Saluda River; thence running along the center of the right-of-way of Moody Bridge Road N. 73-54 E., 202.8 feet to a nail and cap; thence running N. 69-09 E., 143.4 feet to a nail and cap; thence running N. 64-28 E., 131.5 feet to a nail and cap; thence running N. 60-23 E., 157.0 feet to a nail and cap; thence running N. 57-40 E., 156.9 feet to a nail and cap in the center of the intersection of the rights-of-way of Moody Bridge Road and Old Road, the point and place of beginning, said tract containing 3.3 acres, more or less.
