ALL that piece, parcel or tract of land, containing 5.25 acres, more or less, off the eastern side of Little Texas Road, in O'Neal Township, Greenville County, South Carolina, being shown and designated as Tract No. 14, on a plat of TALL PINES ESTATES, made by R. B. Bruce, Surveyor, recorded on July 18, 1978, in the RMC Office for Greenville County, S. C., in Plat Book 6-H, page 64, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point in the center line of an easement at the joint corners of Tract Nos. 13 and 14 thereon and running thence with the line of Tract No. 13, S. 61-16 E., 383.1 feet to an iron pin; thence along the line of property conveyed to Norwood Batson, S. 8-29 E., 445.9 feet to an iron pin; thence along the line of Mountainview Acres Subdivision, N. 35-53 W., 478.- feet to an iron pin; thence along the rear lines of Tract 1A, 1, 2, 3 and an easement, N. 7-23 E. 570.5 feet to the point of BEGINNING.
