the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Carolyn Thomason and Peggy Swearinger, their heirs and assigns forever:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the Town of Simpsonville, being located on the eastern corner of the intersection of Beechwood Drive and northern Laurens Road (old U. S. Highway 276) and being shown and designated as 0.66 acres on plat entitled property of J. R. Richardson, Sr., dated July 11, 1963, revised June 29, 1966, prepared by C. L. Riddle, and having, according to said plat, the following metes and bounds, to-wit:
