Waldrop and Tom S. Bruce, Sr.", prepared by Jones Engineering Service, dated October 7, 1980, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the western intersection of Montgomery Avenue and Old Buncombe Road and running thence with the southwestern side of Old Buncombe Road, N. 31-04 W. 83 feet to an iron pin; running thence S. 56-26 W. 81.4 feet to an iron pin; running thence S. 33-30 E. 83 feet to an iron pin on the northern side of Montgomery Avenue; running thence with the northern side of Montgomery Avenue, N. 56-30 E. 86 feet to the point of beginning.

Office for Greenville County in Deed Book 317, at Page 161. George P. Manos died October 18, 1955 as is more fully shown in the Office of the Probate Court for Greenville County in Apartment 641, File 11. Under his will, he devised all of his property to Bessie Manos. Bessie G. Manos died December 10, 1979, as is more fully shown in the Office of the Probate Court for Greenville County in Apartment 1587, File 8. Under the terms of her Will, she authorized her Executors, Jimmy George Manos, Peter Andrew Leventis, and Andrew Leventis, Jr. to sell her property. This deed is executed by Peter Andrew Leventis, as one of the Executors, pursuant to authority
