All that piece, parcel or lot of land in Greenville County, State of South Carolina, near Beverly Road, and adjoining a lot of land now owned by grantees herein which was conveyed to them by the father of the grantor, and being all of the remainder of the land of J. W. Hembree, deceased, and described as follows:
