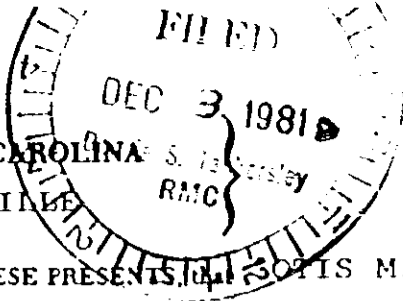

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

ALVIE A. EMERSON and MARY R. EMERSON, THEIR HEIRS AND ASSIGNS FOREVER:

ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, containing approximately 2.50 acres, more or less, and being cut from the Southwesterly side of Tracts 4, 5 and a portion of 2, on a plat of Standing Springs, Section II, recorded in the RMC Office for Greenville County in Plat Book 4-F, page 31, and being known and designated as a portion of Tax Map Number 574.2-1-34 and 37.1, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point in or near the center of W. Georgia Road, in accordance with said plat referenced above, at the joint front corner of Lots #1 and #2, and running thence N. 32-13 W., 235.63 feet to a point; thence N. 86-37 W., 186.7 feet to a point; thence N. 56-01 W., 247.1 feet to an iron pin; thence N. 40-54 W., 416.7 feet to an iron pin; thence along the joint line of 5 and 4-A, S. 54-04 W., 233.9 feet to a point; thence N. 40-54 W., 302.8 feet to a point; thence N. 53-11 E., 283.90 feet to an iron pin; thence S. 40-49 E., 713.8 feet to an iron pin; thence S. 39-51 W., 25 feet to a point; thence S. 56-01 E., 247.1 feet to a point; thence S. 86-37 E., 186.7 feet to a point; thence S. 32-13 E., 235.63 feet to a point; thence turning and running along W. Georgia Road, S. 39-51 W., 25 feet to the point of beginning.
