ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, near Cross Roads Baptist Church, being bounded on the north by property formerly of J. B. Taylor, on the eastern side by lot of L. G. Allen, on the south by property formerly of Anne L.
