All those two pieces, parcels or lots of land with the buildings and improvements thereon, situate, lying and being in Greenville Township, Greenville County, State of South Carolina, known and designated as Lots Nos. 14 and 16 in Block A of Sunny Slope as per plat recorded in Book F, page 86, RMC Office for Greenville County, and being more particularly described as follows:
