the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Johnnie W. Murrell and Valoree R. Murrell, their heirs and assigns forever:

ALL that piece, parcel or lot of land situate, lying and being in Oaklawn Township, Greenville County, South Carolina, containing 4.30 acres, more or less, on the southwestern side of Slatton Shoals Road, and being the same property shown on a plat of "Survey for Johnnie W. & Valoree R. Murrell", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 8X at Page 9, reference to which is hereby made, and having according to said plat the following metes and bounds:

BEGINNING at an old spike in the center of Slatton Shoals Road and running thence along a line of property of Steve & Brenda Davis, S. 29-59-49 W. 407.76 feet to an old iron pin; thence along a line of property of John H.
