KNOW ALL MEN BY THESE PRESENTS, I, ROBERT PENNIE

in consideration of TWO Thousand Four Hundred Sixty-seven and 49/100 (\$2,467.49) -- Dollars
and assumption of mortgage indebtedness as set forth below
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto CHARLES V. HENDERSON, his heirs and assigns:

ALL that certain piece, parcel or lot of land situate, lying and being
in the State of South Carolina, County of Greenville, Gantt Township,
being known and designated as Lot No. 26 of a subdivision of the
PROPERTY OF LANCO, INC., as shown on plat prepared by R. K. Campbell
and Webb Surveying & Mapping Co., October, 1963, and recorded in the
RMC Office for Greenville County, S. C., in Plat Book RR, page 199,
and having, according to said plat, the following metes and bounds,
to-wit:

BEGINNING at an iron pin on the western side of Malone Street, joint
front corner of Lots 25 and 26; thence with the joint line of said
lots, S. 71-29 W., 199.4 feet to an iron pin, joint rear corner of
Lots 25 and 26, thence with the rear line of Lot 26, N. 25-30 W., 70
feet to an iron pin at the joint rear corner of Lots 26 and 27;
thence with the joint line of said lots, N. 71-20 E., 208 feet to an
iron pin on the western side of Malone Street; thence with the western
side of Malone Street, S. 18-30 E., 70 feet to the point of beginning.

The above property is the same conveyed to the Grantor by deed of
Southern Investments, a General Partnership, of even date, to be
recorded simultaneously herewith, and is hereby conveyed subject to
all rights of way, easements, conditions, public roads and restrictive
covenants reserved on plats and other instruments of public record
and actually existing on the ground affecting said property.

As a part of the consideration for this deed, the Grantee assumes and
agrees to pay in full the indebtedness due on a note and mortgage
given to South Carolina Federal Savings and Loan Association (formerly
Security Federal Savings and Loan), in the original sum of \$17,800.00,
recorded in Mortgage Book 1199, page 623, in the RMC Office for
Greenville County, S. C., which has a present balance due in the sum
of \$15,320.60.

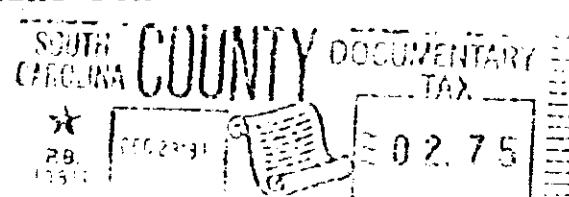
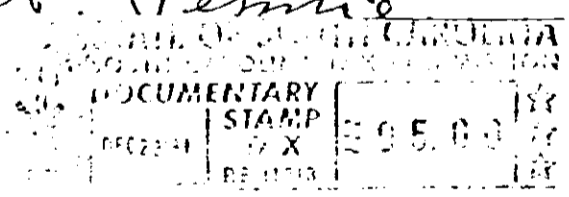
