

Parcel 5. All of Lot No. 107 as shown on said plat having metes and bounds according to said plat, to wit: Beginning at an iron pin in the northern edge of a ten foot alley joint rear corner of Lots Nos. 107 and 108, said iron pin being 320 feet more or less west of the intersection of the northern edge of said ten foot alley and the western edge of Woodside Circle (Fourth Street); thence with the northern edge of said ten foot alley S. 64-58 W. 79 feet to an iron pin; thence N. 25.05 W. 117 feet to an iron pin in the southern edge of Iselin Street (Second Street); thence with the southern edge of Iselin Street N. 64-58 E. 79 feet to an iron pin, joint front corner of Lots 107 and 108; thence with the line of Lot 108 S. 25-02 E. 117 feet to the beginning corner, said lot containing .21 acres according to said plat.

Parcel 6. Beginning at an iron pin in the southern edge of Woodside Circle (Fourth Street) said iron pin being a distance of 240.3 feet on a course of S. 54-36 W. from an iron pin at the intersection of the eastern edge of Green Avenue with the northern edge of Woodside Circle, said beginning point also being at the northwestern corner of Lot 149 as shown on said plat; thence with the line of Lot 149 S. 25-04 E. 75-55 feet to an iron pin; thence S. 67-38 W. 148.7 feet to an iron pin; thence N. 79-40 W. 82.7 feet to an iron pin; thence S. 51-24 W. 114.1 feet to an iron pin; thence S. 89-05 W. 215.25 feet to an iron pin; thence N. 34-38 W. 84.5 feet to an iron pin; thence N. 67-05 W. 150.7 feet to an iron pin; thence N. 67-37 W. 120.9 feet to an iron pin; thence N. 72-55 W. 100.1 feet to an iron pin; thence S. 87-10 W. 120.4 feet to an iron pin; thence N. 25-05 W. 34.55 feet to an iron pin in the southern edge of a ten foot alley; thence with the southern edge of said ten foot alley N. 64-57 E. 399.0 feet to an iron pin at the intersection of the southern edge of said ten foot alley with the western edge of Woodside Circle; thence with the edge of Woodside Circle S. 24-53 E. 222.0 feet to an iron pin; thence continuing with the edge of Woodside Circle S. 34-14 E. 106.4 feet to an iron pin; thence continuing with the edge of Woodside Circle S. 55-08 E. 120.3 feet to an iron pin; thence continuing with the edge of Woodside Circle S. 88-01 E. 125.8 feet to an iron pin; thence continuing with the edge of Woodside Circle N. 64-51 E. 326.85 feet to the beginning point, said parcel containing 2.36 acres according to said plat.

Parcel 7. Beginning at a point in creek said point being 97.55 feet from an iron pin in the southern edge of Woodside Circle (Fourth Street) being the joint front corner of Lot No. 145 and of parcel 6 described above; thence with the line of Lot 149 N. 25-04 W. 22 feet to an iron pin, the southeastern corner of the parcel 6, described above; thence with the line of parcel 6 S. 67-38 W. 148.7 feet to an iron pin; thence continuing with said line N. 79-40 W. 82.7 feet to an iron pin; thence continuing with said line S. 51-24 W. 114.1 feet to an iron pin; thence continuing with
