the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto
Lucille Christopher, her heirs and assigns forever:

"All of that parcel or lot of land in Chick Springs Township of Greenville County, South Carolina, in the City of Greer, lying on the South side of Springdale Avenue, being the western one-half of Lot No. 79 as shown on a plat of the N. M. Cannon property, made by H. S. Brockman, Surveyor, dated January 16, 1924, recorded in the R.M.C. Office for Greenville County in Plat Book F, at page 199 and having the following courses and distances:

Beginning on an iron pin on the South Side of Springdale Avenue, joint front corner of Lot Nos. 79 and 80 on said plat, and runs thence with the common line of these Lots S. 13.00 E. 169.7 feet to a point or stake, joint rear corner of Lots Nos. 79 and 80; thence N. 77.00 E. 25 feet to a point on back line of Lot No. 79; thence a new line exactly with the center of Lot No. 79 N. 13.00 W. 169.45 feet to a point on the South side of Springdale Avenue which point is equi-distant from the front corners of Lots No. 79; thence along Springdale Avenue S. 77 W. 25 feet to the beginning corner, and being one-half of Lot No. 79 as devised to Lee Roy Bailey by Jessie Marie Bailey as appears by Will on file in the Probate Court of Greenville County,
