The subject property was conveyed to the late Eloise Wilson by deed of Ansel M. Hawkins, et al, as Executors of the Will of Mary Steadman, recorded on June 21, 1938 in Deed Book 204 at page 305. By deed dated April 8, 1925 and recorded in Deed Book 105 at page 295 the property had been conveyed to the said Mary Steadman and her sister Pernecy Steadman. Pernecy Steadman died testate in 1929 and devised her 1/2 interest in the property to the said Mary Sullivan as appears by reference to Apartment 244, File 6 in the Office of the Probate Court for Greenville County.
