ALL OF OUR RIGHT, TITLE AND INTEREST IN AND TO -

All that certain piece, parcel or tract of land in Greenville County, State of South Carolina, being known and designated as Tract No. 4 on a plat of Property of James Clifford Smith Estate prepared by T. H. Walker, Jr., dated May 15, 1981, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 8N at Page 98, said tract containing 7.891 acres (6.883 acres net). Reference to above plat is hereby craved for a more particular metes and bounds description.

ALSO: All that certain piece, parcel or tract of land in Greenville County, State of South Carolina, being known and designated as Tract No. 5 on a plat of Property of James Clifford Smith Estate prepared by T. H. Walker, Jr., dated May 15, 1981, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 8N at Page 98, said tract containing 20.284 acres (19.380 acres net).
