KNOW ALL MEN BY THESE PRESENTS, that the undersigned, John B. Leatherwood, Roy Leatherwood, Cordia Mae Leatherwood, Effie Leatherwood, Inez Leatherwood, Maud Leatherwood, M. L. Leatherwood, and Emma Leatherwood Pinson, in consideration of the sum of One (\$1.00) Dollar and other valuable considerations to us in hand paid, do hereby make, constitute and appoint Cordia Mae Leatherwood, a resident of Greenville County, South Carolina, as our true and lawful attorney-in-fact for the sole and specific purpose of accepting on our behalf and distributing to us principal and interest to be paid January 5, 1981 and January 5, 1982 pursuant to the terms and provisions of a promissory Note executed in our favor by Donald F. Bolt, as Trustee under Trust Agreement dated December 23, 1980, said Note being in the principal amount of \$83,045.00 dated December 26, 1980, and, upon receipt of all principal and interest due and owing thereunder, to make, execute and deliver unto the said Donald F. Bolt, as Trustee under Trust Agreement dated December 23, 1980, his successors and assigns, such instrument or writing as may be necessary and proper to evidence full payment of all amounts so due and cancellation of the Note and Purchase Money Mortgage executed on December 26, 1980 to evidence and secure the obligations, such Mortgage to be recorded in the RMC Office for Greenville County, South Carolina, covering a 40-acre parcel of land which we have conveyed to Donald F. Bolt, as Trustee, being shown and designated on a survey entitled "Survey For Donald F. Bolt, As Trustee, and John B. Leatherwood, Et Al", dated December 22, 1980, prepared by Williams & Plumblee, Inc.

This Power Of Attorney shall not be affected by the physical disability or mental incompetence of any principal hereto which renders the principal incapable of managing his or her own estate, and the death of any one principal shall not invalidate this Power Of Attorney as to any of the other principals.
