KNOW ALL MEN BY THESE PRESENTS that SHANNON FOREST PRESBYTERIAN CHURCH, INC., a South Carolina Corporation, with its principal office at Route 2, Garlington Road, Greenville, South Carolina 29607, hereinafter sometimes referred to as GRANTOR, for and in consideration of the sum of ONE DOLLAR (\$1.00), at or before the sealing of these presents, in hand to it paid by the GRANTEE, and the receipt whereof is hereby acknowledged, which GRANTEE is THE METROPOLITAN SEWER SUBDISTRICT, P. Does hereby REMISE, RELEASE and QUIT CLAIM unto the said GRANTEE and its successors and assigns forever, the following described REAL ESTATE:

BEING all those sanitary sewer lines, pipes, manholes, valves, and appurtenances, installed and located in or along the following described courses and distances leading from the existing septic tanks located on the property of Shannon Forest Presbyterian Church, Inc., described in deed recorded in Vol. 1029 at Page 864, in the RMC of Greenville County, South Carolina, and leading to a trunk line where the said sanitary sewer lines terminate into the said trunk line, and together with a right-of-way and easement necessary or incident to the operation, maintenance and repair or replacement of said sewer lines and appurtenances, 25 feet in width, which sewer line and right-of-way shall extend along the following course:
