RESOLUTION TO PRESCRIBE AND SET FORTH A REGULATION IN REGARD TO THE REQUIREMENT OF A PERMIT TO CONNECT AND USE SEWER FACILITIES

WHEREAS, difficulties have arisen because of a lack of coordination by the persons building or constructing various residences and other projects, Western Carolina Regional Sewer Authority, the various subdistricts and municipalities, the Planning Commission, and County Codes Department, and

WHEREAS, the County Codes Department is best suited to receive information and coordinate permitting and does not need to issue a building permit until such availability is ascertained,

NOW, THEREFORE, BE IT RESOLVED that the Authority, pursuant to the powers delegated to it, does hereby adopt the following regulation:

1. No person, corporation, partnership or other entity shall connect to any sewer line or use any sewer collection facility of any subdistrict or municipality served by Western Carolina, or to any line owned or operated by Western Carolina, who shall not first have applied for and obtained a permit granting approval for such connection and use from the subdistrict or municipality having jurisdiction and from Western Carolina Regional Sewer Authority. The application and approval form shall be as set forth on the attached Exhibit "A".

2. No approval for connection or use shall be granted by any district or municipality served by Western Carolina or by Western Carolina until it shall first be ascertained that sewer collection service is available and further that a treatment capacity for the waste intended to be discharged is available.

3. All permits granting approval may be made subject to special terms and conditions applicable to the circumstances existing at the time and shall be subject to all applicable laws, rules and regulations.

4. No permit shall be transferable or assignable without the consent of the public bodies granting approval.

This Resolution shall take effect as of February 14, 1982. A copy of the Resolution shall be delivered to the County Codes Administrator of Greenville County and his counterparts in Laurens and Anderson counties, with the request that no building permit be issued until the applicant applies for and receives approval.
