Kennedy, as Trustee for the Trust of Linda Carole Kennedy and Lara Anne Kennedy, under the Short term Trust Agreement dated the 1st day of October, 1980, and her successors and assigns.

An Undivided twenty-five (25%) per cent interest in the below described property. (This being 12.5% from each Grantor.)

THAT parcel, piece or tract of land with all buildings and improvements thereon situate, lying and being in the County of Greenville, State of South Carolina on South Carolina Highway Number 20 and containing 0.573 acres according to the plat of property of Max W. Kennedy and Gwen Kennedy, made by Dalton & Neves, Engineers, dated August, 1980, recorded in the R.M.C.
