the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Ollie Belle Wade McKinney; her heirs and assigns forever:

ALL our right title and interest in and to ALL that certain piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, on the south side of Watkins Bridge Road, west side of Watkins Road being known and designated as 1.82 acre tract of land as shown on plat of property of G. P. Wade, Dovie Wade and Belle W. McKinney made by Tri-State Surveyors dated September 15, 1981, recorded in the RMC Office for Greenville County, S.C. in Plat Book 8-Y at Page 3 and having according to said plat the following metes and bounds, to-wit:
