in consideration of Fourteen Thousand and No/100ths Dollars,

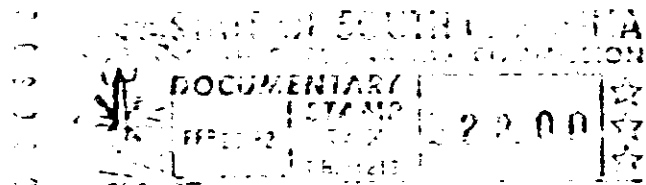
