ALL that certain piece, parcel or lot of land situate, lying and being in Paris Mountain Township, County of Greenville, State of South Carolina, being known and designated as the eastern half of Lot No. 23, as shown on plat of the Nabors & Bridges Property, recorded in the RMC Office for Greenville County in Plat Book O at Page 195, and having, according to a more recent survey made by J.
