All that piece, parcel or lot of land with the buildings and improvements thereon, lying and being in Chick Springs Township, Greenville County, South Carolina, about one mile west of Fairview Baptist Church near the Chick Springs-O'Neal Road and being shown as part of Lot # 5 on the Plat of Robert Lee Miller Estate made by J. Earle Freeman, Registered Surveyor, on April 16, 1940, and having according to said plat the following metes and bounds, to wit:

BEGINNING at a point in the road at the joint front corner of Lot # 5 and the lot designated as the Allen Lot and thence along the joint line of said lots N. 18-3/4 W. 4.09 chains to an iron pin, joint corner of said lots 5&6 and the Allen lot; thence along the joint line with lots 5 and 6 N. 18-1/4 W. 5.00 chains to an iron pin, joint corner of said lots with a portion of Lot #5 previously conveyed by Sallie M.
