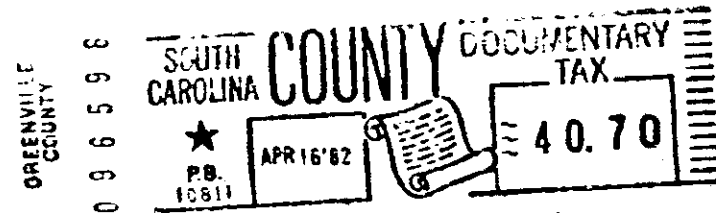
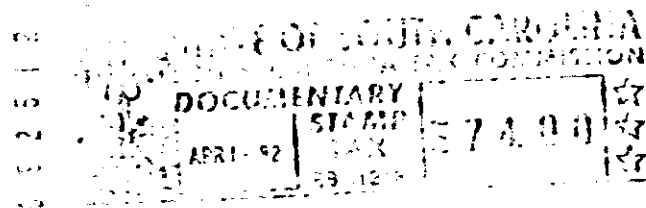
KNOW ALL MEN BY THESE PRESENTS, that BUILDERS & DEVELOPERS, INC.
