LIMITED DURABLE
POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS that I, ROGENE LESLIE BOYLES, a resident of Greenville County in the State aforesaid, do hereby nominate, constitute and appoint my friend, HELEN AUSTIN, now residing in Greenville, South Carolina, as my true and lawful Attorney-in-Fact for me and in my name, place and stead and for my use and benefit for the purposes herein-after set forth. My Attorney-in-Fact shall not be required to furnish bond nor to account to any Court for the faithful performance of her estate.

I hereby grant unto my Attorney-in-Fact the following powers:

1. To transfer, set over, assign and convey all and any right, title and interest of mine in and to any property, real or personal, to THE CITIZENS AND SOUTHERN BANK OF SOUTH CAROLINA, Greenville, South Carolina, as Trustee, under that certain Trust Agreement dated April 15, 1982, by and between ROGENE LESLIE BOYLES, as Grantor, and THE CITIZENS AND SOUTHERN BANK OF SOUTH CAROLINA, Greenville, South Carolina, as Trustee.

2. To execute any change of beneficiary on any policy of insurance on my life by naming as beneficiary THE CITIZENS AND SOUTHERN NATIONAL BANK OF SOUTH CAROLINA, Greenville, South Carolina, Trustee under that certain Trust Agreement dated April 15, 1982, entered into by and between ROGENE LESLIE BOYLES, as Grantor, and THE CITIZENS AND SOUTHERN NATIONAL BANK OF SOUTH CAROLINA, Greenville, South Carolina, as Trustee.

3. To execute any stock power, affidavit, or other instrument required by any transfer agent to transfer any stock certificate, bond or other security to THE CITIZENS AND SOUTHERN NATIONAL BANK OF SOUTH CAROLINA, Greenville, South Carolina, Trustee under the aforesaid Trust Agreement dated April 15, 1982. Any transfer agent, insurance company, or other third party is authorized to rely on a certified copy of this instrument so certified by a Notary Public for South Carolina.

4. To amend that certain Trust Agreement between ROGENE LESLIE BOYLES, as Grantor, and THE CITIZENS AND SOUTHERN NATIONAL BANK OF SOUTH CAROLINA, Greenville, South Carolina, as Trustee, dated April 15, 1982, except my Attorney-in-Fact shall not have the power to change the provisions as to distribution of income or corpus of the Trust.
