**Morris King and Blanche King, their heirs and assigns forever:**

ALL that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Highland Township, about one-half (1/2) mile west of Blue Ridge High School, lying on the north side of the road formerly known as New Cut Road, now known as Blue Ridge Drive, and being a part of the 6.51-acre lot conveyed to Elbert H. Mosteller by deed and recorded in the Office of the RMC for Greenville County in Deed Book 637, at Page 198, and having the following courses and distances, to-wit:

BEGINNING on a point in the center of the said Blue Ridge Drive, joint corner of lands, now or formerly, of C. O. Johnson, and runs thence with the common line of this lot and the Johnson land, N. 15-00 W. 25 feet to an iron pin (old) on the north margin of the said road; thence continuing with the same course for a total distance of 421 feet to an iron pin on the Johnson line; thence a new line, S. 76-45 W. 102 feet to an iron pin; thence, S. 1-15 E. 112 feet to an iron pin, new corner; thence, S. 15-35 E. into the driveway from the Blue Ridge Drive to the trailer located on the said lot 246 feet to an iron pin over the western end of the culvert in the northern ditch of the said drive; thence, S. 75-10 E. 140.14 feet to the beginning corner, containing one and nine-one-hundredths (1.09) acres, more or less.
