All that lot, track or parcel of land in Chick Springs Township, County of Greenville, State of South Carolina, being a part of the original fourteen acre tract of land deeded to the Trustees of Saint Mark Church by Charles T. Hopkins and others during the year of 1877, said lot consisting of 3.58 acres, more or less, according to a survey made by J. Earle Freeman on November 20, 1934, having the following metes and bounds:

Beginning on I.P. on Anderson line (King Greer Corner), thence N. 17 1/2 E. 7.67 chains to stone at Hickory Stump, thence S. 56 1/2 E. 4.52 chains to small spruce pine, thence S. 13 W. 6.54 chains to I.P., thence N. 71 & 3/4 W. 4.82 chains to the beginning corner, and containing three and fifty-eight hundredths (3.58) acres, more or less according to survey made by J. Earle Freeman, November 20, 1934.
