ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina being shown on plat of survey at the request of Gordon Shelley, prepared by J. L. Montgomery, III, R.L.S., dated April 22, 1982, recorded in the RMC Office for Greenville County in Plat Book 9B at page 48 and having, according to said plat, the following metes and bounds to-wit:
