The above property is a portion of that real property conveyed to Leila J. Brown by Deed of G. Dewey Oxner dated January 13th, 1956 and recorded in Book 543 at Page 250 in the R. M. C. Office for Greenville County. Leila J. Brown died intestate in December of 1980 leaving the grantors and grantee as her sole heirs, the estate of Leila J. Brown being probated in Department 1632 at File 21. Jessie Lee Edwards was also an heir of Leila J. Brown, however, she died intestate on December 12th, 1981 leaving Brinton Edwards as her only heir.
