to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto H. G. Proffitt, Inc., its successors and assigns:

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being at the westerly intersection of Hunting Hill Circle and Ladyslipper Lane, near the City of Greenville, South Carolina, being known and designated as Lot No. 516 on plat entitled, "Map Four, Section Two, Sugar Creek" as recorded in the R.M.C.
