NINE HUNDRED FIFTY and no/100 (\$124,950.00) Dollars,

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto
John A. Bolen, his heirs and assigns forever:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of
South Carolina, County of Greenville, being known and designated as Lot No. 119 of a
subdivision known as Pebble Creek, Phase I, as shown on plat thereof recorded in the
RMC Office for Greenville County, South Carolina, in Plat Book 5D, Pages 1-5, and having,
according to said plat, such metes and bounds as appear thereon.

This conveyance is made subject to any zoning ordinances or easements that may appear
of record, on the recorded plat, or on the premises.

ALSO, a perpetual right of way and easement for ingress and egress over and across that
certain 20-foot strip crossing Lot Nos. 118, 119, 120 and 121, said strip being known as
Fairway One and being a common driveway for Lot Nos. 118, 119, 120 and 121. Grantee(s),
their heirs and assigns, shall have the right to use said Fairway One in common with the
owners of Lot Nos. 118, 119, 120 and 121 as a means of ingress and egress to and from
Stallings Road. Grantee(s), by acceptance of this deed, do hereby agree to keep that
portion of said 20-foot strip crossing Lot No. 119 maintained in a good passable condition.

Grantor, for itself, its successors and assigns, does hereby reserve a perpetual right
of way and easement over and across that certain 20-foot strip hereinabove described
and does hereby reserve the right to use said strip in common with the owners of Lot
Nos. 118, 119, 120 and 121 as a means of ingress and egress to and from Stallings Road.
